# 1.0 Notice to All Users

## **IMPORTANT:**

INSTALLING OR USING CADS SOFTWARE CONSTITUTES ACCEPTANCE OF THIS AGREEMENT.

Computer and Design Services Ltd (CADS) is willing to licence its software to you only on the condition that you accept all of the terms contained in the Licence Agreement overleaf which has 33 Clauses.

It is a legal agreement between you (either as an individual, firm, partnership, sole trader, corporate entity or organisation) as the End User and Computer and Design Services Ltd as the author or distributor for the software product or products identified below.

The Software is protected by Copyright Laws and by international provisions as with other intellectual property. The Software is licensed not sold. Title to and ownership of the intellectual property rights associated with the Software Application and any copies remain with CADS and its suppliers.

By installing this software, you, whether as owner or lessee of the Licence, agree to be bound by the terms and conditions of this agreement and to procure that your employees or those working for you in any capacity, direct or indirect, comply with its full terms. If you do not agree to the terms and conditions of this Agreement then you must not install, register, copy or use the software.

This page is for information and does not form part of the Licencing Agreement.

## 1.1 Parties

This Licence is a legal agreement between Computer and Design Services Limited, Arrowsmith Court, 10 Station Approach, Broadstone, Dorset BH18 8AX ("CADS") and the End User hereinafter referred to as the "Licensee", being the person, individual, firm, partnership, sole trader, corporate entity or organisation named on:

the CADS Confirmation of Order Form(s) or

the CADS Acknowledgement of Order Form(s) or

the CADS CD or DVD Licence Form

by whom or on whose behalf this Licence is agreed by ticking the acceptance box at the end of the Licence displayed on initial installation of the software.

## 1.2 The Software

This Licence governs the Licensee's use of the CADS Software Application(s) named on  
CADS Confirmation of Order Form(s) or  
CADS Acknowledgement of Order Form(s) or  
CADS CD or DVD Licence Form(s)

including its programs, documentation, subsequent corrections, additions and modifications ("the Software"). This Licence shall replace and discharge all prior representations and agreements (if any) relating to use of the Software. In case of conflict, the terms of this Licence shall over-ride any terms or conditions imposed by the Licensee.

## 1.3 The Licence

CADS owns or is otherwise authorised to licence the software and in consideration of you, the Licensee, agreeing to abide by the terms and conditions of this Licence, and subject to the payment of applicable licence and other related fees, hereby grants the Licensee a non-exclusive, non-transferable right to use the Software Application but only on the Licensee's compatible computer system or systems, or devices for the Licensee's internal business operations subject to the terms and conditions of this Licence. The Software is in use on a computer when it is loaded into the temporary memory or installed into the permanent memory. The Licensee shall not install, access or otherwise copy or use the Software except as expressly authorised by this Agreement and the Licensee agrees not to use the Software for any re-sale purposes.

Where the software is supplied on a Single User USB Hardware Key (Dongle) basis the Licensee may install as many copies of the software as is required on compatible computers but shall only use the software on one compatible computer at a time with the Dongle attached.

Where the software is supplied on a Single User basis to be used with a CADS Single-User Software Licence the Licensee may install one copy of the Software on one Central Processing Unit (CPU) of the compatible computer and may also keep one copy of the Software for security or archival purposes only. Except for such security copy, no other copies of any part of the Software not incidental to use of the Software as permitted in Clause 3 above shall be made and the Licensee shall not download the Software to or permit it to be accessed from any unlicensed equipment or by any third party. Should the Licensee wish to cease to use the software on the computer on which it has been installed then it can be removed without further reference. If the Licensee wishes to install the software on a different compatible computer then the Software Licence may be transferred with the assistance of the CADS Technical Support Team.

Where the software is supplied on a multi concurrent user basis on a Local Area or Wide Area Network the Licensee may install as many copies of the software as required on compatible computers with

the Network Dongle or the CADS Floating-Network Software Licence installed on the Network Server. The Licensee shall at no time use more copies of the software than have been authorised by the Network Dongle or the Software Licence.

Where the Licensee is supplied with software for a Virtual Server or a Server and dumb terminal installation then a Network Dongle will be required at the virtual server that has been authorised for each copy of the software that is being used.

The Licensee agrees that any copies of the Software Application shall contain the same proprietary notices which appear on and in the Software Application.

The Licensee will not attempt to alter, modify, translate, reverse engineer, decompile, decrypt, extract, or disassemble or copy the software either in whole or part or incorporate it within any other software or to emulate or reverse engineer the Dongle so that the software may be used without the authorised Dongle issued by CADS or any third party.

The Licensee further agrees that it shall not itself or through any subsidiary agent or third party modify vary, enhance, copy, sell, lease, licence, sub-licence, grant a security interest in or otherwise deal with the Software and or the Dongle and or the Software Licence or any part or parts or variations, modifications, copies releases, versions or enhancements or have any Software or other programme written or developed for itself based on any proprietary and/or confidential, information supplied to it by CADS otherwise than in accordance with the provisions of this Licence and without first having obtained the written consent of CADS.

Nothing in this Licence permits the Licensee to derive the source or assembly code of files that are provided to the Licensee in executable form.

## 1.4 Distribution by Licensee

The Licensee shall not distribute, rent, loan, lease, sell, sub-licence, or otherwise transfer all or any portion of the Software Application, or any rights granted in this Agreement, to any other person without the prior written consent of CADS. The Licensee shall not install or access, or allow the installation or access of, the Software Application over the Internet, including, without limitation, use in connection with a Web hosting or similar service, or make the Software Application available to third parties via the Internet on an End-User's computer system or otherwise.

The Licensee shall not modify, translate, adapt, arrange, or create derivative works based on the Software Application for any purpose. The Licensee may not use or export the Software Application outside of the country of purchase for any reason. The Licensee shall not assign, give or transfer the Software Application to another individual or entity. The Licensee is prohibited from (a) timesharing, service bureau, subscription service or rental use of the Software Application or (b) passing title to the Software Application to any other individual or (c) publication of any results of benchmark tests run

on the Software Application. The Licensee acknowledges that the Software Application is the confidential information of CADS and its suppliers, and the Licensee agrees that under no circumstances may the Licensee disclose the Software Application to any third party.

## 1.5 Payment of Licence Fees

In consideration of the grant of the Licence, the Licensee agrees to pay CADS all licence fees and other charges payable by virtue of the provisions of this Licence and acknowledges that CADS may issue upgraded versions of the Software to the Licensee for an extra fee, the amount of which will be determined at the absolute discretion of CADS. The Licensee shall be entitled to receive the upgraded Software only after it has paid CADS the notified fee.

## 1.6 Enhancement and Variations to the Software

The Licensee shall not enhance or vary any part of the Software nor permit the whole or any part of the Software to be incorporated in any other software or used on any other equipment.

## 1.7 Additional Licences

CADS will on request provide additional licences to increase the number of licensed Software users subject to the Licensee paying the then current market price and cost of the Software.

## 1.8 Use of the Software by the Licensee

The Licensee shall use the software on the device or system at each and every location where it is installed in accordance with the following and for the purpose of this licence use of software shall mean:

- to store and/or run the Software on the System or device in accordance with the terms of this Licence
- to process data or instructions using the software
- to make a copy of the machine readable form of the Software for security and back up purposes.

The Licensee shall procure and ensure that all users of any CADS Software that is Licenced to him, whether employees, sub-contractors, associates, affiliates, subsidiary or sister organisations abide by all the terms of the Licence.





## 1.9 Non Bespoke Software

The Licensee acknowledges that the Software has not been developed to meet the Licensee's individual requirements, and that it is therefore the Licensees responsibility to ensure that the facilities and functions of the Software as described in the Documentation meet their requirements.

### 1.10 Software Application Function

In particular, the Software is not intended for use as a tool to ensure compliance with any laws, obligations, regulations guidance or codes of practice including but not limited to matters of Health and Safety. Any diagrams that may be included in the software or documentation are for information purposes only and are not detailed technical drawings and may omit components or features that are required in practice. Whilst reasonable efforts have been made to ensure that the Software and Documentation is accurate, CADS do not accept any responsibility for any associated errors, omissions or misleading statements. Except as specified in the Limitation of liability section of Clause 15 of this licence and to the extent lawfully permitted CADS hereby excludes all liability in connection with this Software and Documentation and any reliance you may place on the Software and/or Documentation.

### 1.11 Users of Software to be Proficient

The software must only be used by suitably trained and skilled staff as an aid to design and specification and it is not intended as and must never be used as a substitute for professional skill, experience or expertise. The Licensee should always ensure that users of the Software either have themselves the necessary skill and experience or recourse to the necessary advice specific to the circumstances for which the software is being used and that it is not a substitute for on-site assessment.

### 1.12 Maintenance and Support

CADS will, in respect of the software in Clause 1.2, on payment in advance of the appropriate maintenance fee, provide an annual Maintenance and Support Service. The terms under which such Maintenance and Support Services are supplied are set out on CADS website.

### 1.13 Intellectual Property & Confidentiality

Subject to the rights granted to the Licensee by this Licence, the Licensee acknowledges that all and any proprietary rights in the Software worldwide, (including but not limited to copyright) and in all associated documentation and other materials related to the Software shall be and remain the sole property of CADS or its suppliers.

The Software and all information, data, drawings, sketches, specifications, documents, software listings, source code, or object code is proprietary, secret and confidential to CADS. The Licensee hereby agrees that it shall use such information solely in accordance with the provisions of this Licence and that it shall take all measures necessary to maintain confidence and secrecy in the Software both for the duration of this Licence and after its termination, howsoever caused. Disclosure shall be limited to those members of the Licensee's staff who need access to the Software to enable the Licensee to exercise this Licence and shall not be to any Third Party. These confidentiality obligations extend to the structure, sequence, organisation and screen presentation of the Software.

## 1.14 Indemnity and Warranties

CADS warrants to the Licensee that the Software will not infringe any copyright, patent or other intellectual property rights of any third party.

The Licensee shall promptly give notice to CADS of any claim alleging infringement of any intellectual property right of any third party by the Software and CADS shall at its discretion either compromise or defend such claims. CADS shall have the right to replace or change the Software so as to avoid infringement of any third party's intellectual property rights.

CADS warrants that for a period of 90 days the Software will when delivered perform substantially in accordance with CADS's published specifications but does not warrant that the Software is error free. Faulty media and documentation will be replaced during the warranty period free of charge on receipt by CADS of written notification from the Licensee setting out details of faults. The Licensee is responsible for loss or damage of all dongles received from CADS as part of the Licence. In case of loss of a dongle, CADS has the right to terminate the Licence and CADS is not obligated to replace any lost dongle. Damaged dongles may be returned to CADS and will be replaced, but CADS reserves the right to charge additional fees to cover the costs in that case. This warranty does not apply if the defect or fault in the Software results from the Licensee having amended or attempted to amend the Software or if the defect or fault in the Software results from the Licensee having used the Software in contravention of the terms of this Licence.

## 1.15 Liability

CADS and its suppliers shall not be liable for any loss or damages, direct or indirect, consequential or financial suffered by the Licensee caused by the delivery, use or performance of the Software or for negligence or breach of contract by CADS in relation to the Software whether foreseeable or not and regardless of whether the Licensee or its suppliers have been advised of the possibility of such damages.

Because CADS has no control over the way in which the Software may be used, the Licensee shall indemnify CADS against all third-party claims which may arise from possession or use of the Software

not being claims of the kind described in Clause 9 above. CADS shall have no support or error correction obligation in respect of the Software other than as provided in Clause 10 above or by the terms of a separate Maintenance and Support Agreement made between the parties.

CADS and its suppliers shall not under any circumstances whatsoever be liable to you, whether in contract, tort (including negligence), breach of statutory duty, or otherwise arising under or in connection with the licence including without limitation:

1. loss of profits, sales, business, or revenue
2. business interruption
3. loss of anticipated savings
4. liability or injury to third persons
5. loss or corruption of data or information
6. loss of business opportunity, goodwill or reputation or
7. any indirect, special or consequential loss or damage of any nature

## 1.16 Liability Limits

Other than the losses set out in Clause 15 (for which CADS are not liable) the maximum aggregate of the liability of CADS under or in connection with this Licence whether in contract, tort (including negligence) or otherwise, shall in all circumstances be limited to the price paid for the Software.

Nothing in this licence shall limit or exclude our liability for:

1. death or personal injury resulting from our negligence
2. any other liability that cannot be excluded or limited by English law.

## 1.17 Privacy Statement

CADS respects your right to privacy. Our software may collect and analyse general usage information about hardware, its configuration, software usage patterns, design outcomes and error reports to help us improve the quality of our service. We will not collect personal information about individual users and do not sell or otherwise give away any such information to unaffiliated third parties unless legally compelled to do so.



## 1.18 Audit Rights

At any time during the Licence Term, CADS or its re-seller in any location may conduct or appoint an external auditor to conduct an audit in order to ensure compliance by the Customer with the terms of any Licences of CADS Software Applications. CADS or its re-seller as applicable shall provide no less than five days advance notice of Audit to the customer unless the Audit is carried out electronically.

The Customer shall grant the Licensor CADS or the appointed external auditor reasonable assistance and co-operation and such access to premises, systems and other such material and data as may be reasonably necessary to determine the Customer's compliance with any CADS licensing agreements. CADS or its external auditor shall ensure that such Audit will not interfere unreasonably with the legitimate business activities of the customer.

The Audit may also be conducted electronically utilising the Audit functionality of the Software designed to enable CADS to automatically monitor the use of its software. The Customer expressly agrees and consents to such monitoring and the reporting of it to CADS to detect and notify CADS of CADS software installations or third party applications provided by CADS and the use of any unlicensed CADS software. That an electronic Audit has been carried out does not limit CADS right to carry out further Audits through non-electronic means.

Should the Audit whether electronic or physical determine that the Customer is not in compliance with the Terms of the Licence for use issued by CADS, the Customer shall immediately remedy the situation either through purchase and payment for additional Licences or otherwise as well as compensating CADS for the cost of the Audit. Such compensation for costs shall be without prejudice to any rights or remedies that may be available to CADS whether at law or in equity, and whether due to any breach by the Customer of this Agreement.

## 1.19 CADS Obligations

This Licence sets out the full extent of CADS obligations and liabilities in respect of the supply of the Software and Documentation. Except as expressly stated in this licence there are no conditions warranties, representations or other terms, express or implied, that are binding on us. Any condition, warranty, representation or other term concerning the supply of the Software and Documentation which might otherwise be implied into, or incorporated in, this Licence whether by statute, common law or otherwise, is excluded to the fullest extent permitted by law.



## 1.20 Length of Licence

This Licence shall start on the ticking of the acceptance box by the Licensee and shall continue for a period of five years unless earlier terminated. The Licensee may terminate this Licence by giving to CADS 90 days' written notice on its ceasing to use the Software for the purposes of their business.

## 1.21 Termination

CADS may terminate the Licensee's right to use the Software under this Licence on 30 days written notice if the Licensee breaches any of the terms, conditions, or provisions of this Licence or any obligation to CADS required by law or without prejudice to clause 18 above, if the Licensee fails to pay any sum due to CADS whether due under this Licence or not and/or if the Software Maintenance and Support Agreement is terminated (for whatever reason) if the Licensee, being a body corporate, shall present a petition or have a petition that is not discharged or stayed within 30 days presented by a creditor for its winding up, or shall convene a meeting to pass a resolution for voluntary winding up, or shall enter into any liquidation (other than for the purpose of a bona fide reconstruction or amalgamation); shall call a meeting of its creditors, or shall have a receiver of all or any of its undertaking or assets appointed, or shall be deemed by virtue of section 123 of the Insolvency Act 1986 to be able to pay its debts.

## 1.22 Return of Software and Documentation

On termination for whatever reason, the Licensee shall return immediately all copies of the Software and associated Documentation to CADS and shall pay to CADS all costs and expenses, including legal and other fees incurred and all arrears of fees, charges and other payments arising in respect of the Software and the total amount of any Licence fees outstanding under this Licence or otherwise. Termination, howsoever or whenever occasioned shall be subject to the any rights and remedies CADS or its suppliers may have and under this Licence or in law.

## 1.23 Notices

All notices to be given under this Licence shall be in writing and be presented at or posted to the addresses as indicated on the Confirmation of Order Form unless otherwise advised in writing. Notices shall be effective when presented at such addresses or 48 hours after posting if mailed by ordinary first class post.

## 1.24 Assignment

The Licensee shall not be entitled to assign this licence or any of its obligations hereunder. The Licensee agrees that CADS shall be entitled to assign or sub-contract its rights and obligations under this agreement to a third party and the Licensee agrees to enter into a novation of the Licence to achieve such an assignment by CADS if CADS so directs the Licensee.

## 1.25 Third Party Rights

Nothing in this Licence shall confer on any third party any right to enforce any term of this Licence under the Contracts (Rights of Third Parties) Act 1999 .

## 1.26 Taxes

All charges and fees paid are exclusive of and do not include any taxes, duties, or similar charges imposed by any government. The Licensee agrees to pay or reimburse CADS for all federal, state, national, dominion, provincial, or local sales, use, personal property, excise, VAT or other taxes, fees or duties arising out of this agreement or the transactions contemplated by the Agreement.

## 1.27 Law

The parties hereby agree that the Licence concluded between them constructed on these terms and conditions shall be construed in accordance with English Law and the parties shall submit to the non-exclusive jurisdiction of the English Courts.

## 1.28 Headings

The headings of the terms and conditions herein contained are inserted for the convenience or reference only and are not intended to be part of or to affect the meaning or interpretation of any of the terms and conditions of this Licence.

## 1.29 Force Majeure

No Party shall be liable for, nor shall any party be considered in breach of this agreement due to any failure to perform its obligations under this Agreement as a result of a cause beyond its control (each a "Force Majeure Event"), including any act of God or a public enemy, any act of terrorism, act of

military, civil or regulatory authority, change in law or regulation, fire , flood, earthquake, storm or other like event, disruption outage of communications, power or other utility, labour problem, unavailability of supplies, or any other cause, whether similar or dissimilar to any of the foregoing; provided, however that upon learning of any Force Majeure event, the applicable party shall immediately notify the other party of such a Force Majeure Event.

## 1.30 Entire Agreement

This Licence constitutes the entire agreement between the parties in relation to its subject matter and supersedes any prior agreements on these matters and any such agreements shall cease to have any further effect. It is also agreed that neither party has relied upon any representations nor other statements in entering into this Licence other than those set out herein. No purported amendments to this Licence shall be effective unless in writing and signed by duly appointed representatives of all parties.

## 1.31 Acknowledgement

You acknowledge that you and any entity that obtained the Software and on whose behalf it is used and any other user of this installation have read the licence understand it and agree to be bound by its terms and conditions.

## 1.32 Severability

In the event that any of these terms, conditions, provision shall be determined invalid, unlawful or unenforceable to any extent, such term, condition or provisions shall be severed from the remaining terms, conditions and provisions which shall continue to be valid to the fullest extent permitted by law.

## 1.33 Waiver

Failure or neglect by CADS to enforce at any time any of the terms of this Licence shall not be deemed to be a waiver of CADS rights hereunder nor in any way affect the validity of the whole or any part of this Licence nor prejudice CADS rights to take subsequent action.



## 1.34 Export Control

This software product may be subject to trade compliance and export control regulations in the UK and in other jurisdictions, such as the US and EU. By downloading this software, you agree to comply with such applicable laws. CADS reserves the right to terminate your licence if you are found to be affected by such regulations.

## 1.35 Refund Policy

Refunds will only be given under exceptional circumstances and are purely at CADS' discretion. No refunds will be granted more than 15 days after payment.

If you do not agree to the terms and conditions of this License Agreement then you must not install, register, copy or use the Software Application.*

## 1.1 Parties

This License Agreement is a legal agreement between Computer and Design Services Limited, Arrowsmith Court, 10 Station Approach, Broadstone, Dorset BH18 8AX ("CADS") and the End User hereinafter referred to as the "Licensee", being the person, individual, firm, partnership, sole trader, corporate entity or organisation named on:

- the CADS Confirmation of Order Form(s) or
- the CADS Acknowledgement of Order Form(s) or
- the CADS CD or DVD License Form

by whom or on whose behalf this License is agreed by ticking the acceptance box at the end of the License displayed on initial installation of the software.



## 1.2 The Software Application

This License governs the Licensee's use of the CADS Software Application(s) named on:

- CADS Confirmation of Order Form(s) or
- CADS Acknowledgement of Order Form(s) or
- CADS CD or DVD License Form(s)

including its programs, documentation, subsequent corrections, additions and modifications ("Software Application"). This License shall replace and discharge all prior representations and agreements (if any) relating to use of the Software Application. In case of conflict, the terms of this License shall over-ride any terms or conditions imposed by the Licensee.

## 1.3 The License

CADS owns or is otherwise authorised to license the Software Application and in consideration of you, the Licensee, agreeing to abide by the terms and conditions of this License, and subject to the payment of applicable license and other related fees, hereby grants the Licensee a non-exclusive, non-transferable and non-sub licensable right to use the Software Application but only on the Licensee's compatible computer system or systems, or devices for the Licensee's internal business operations and only by its employees and any other entity over which it has direct control subject to the terms and conditions of this License. The Software Application is in use on a computer when it is loaded into the temporary memory or installed into the permanent memory. The Licensee shall not install, access or otherwise copy or use or cause the use of the Software except as expressly authorised by this Agreement and the Licensee agrees not to use the Software Application for any re-sale purposes and/or for Third Party access howsoever effected..

Where the Software Application is supplied on a Single User USB Hardware Key (Dongle) basis the Licensee may install as many copies of the software as is required on compatible computers but shall only use the software on one compatible computer for a single user at a time with the Dongle attached.

The Licensee agrees that it will not itself or through any subsidiary agent or third party to alter, modify, translate, reverse engineer, decompile, decrypt, extract, or disassemble or copy the software either in whole or part or incorporate it within any other software or to emulate or reverse engineer the Dongle or the License File so that the software may be used without the authorised Dongle or License File issued by CADS or any third party.

The Licensee further agrees that it shall not, itself or through any subsidiary agent or third party, modify, vary, enhance, copy, sell, lease, license, sub-license, grant a security interest in or otherwise deal with the Software Application and/or the Dongle and/or the Software License or License File or any part or parts or variations, modifications, copies releases, versions or enhancements or have any Software

Application or other programme written or developed for itself based on any proprietary and/or confidential, information supplied to it by CADS otherwise than in accordance with the provisions of this Software License and without first having obtained the written consent of CADS.

Nothing in this License permits the Licensee to derive the source or assembly code of files that are provided to the Licensee in executable form.

## 1.4 Distribution by Licensee

The Licensee shall not distribute, rent, loan, lease, sell, sub-license, or otherwise transfer all or any portion of the Software Application, or any rights granted in this License Agreement, to any other person without the prior written consent of CADS. The Licensee shall not install or access, or allow the installation or access of, the Software Application over the Internet, including, without limitation, use in connection with a Web hosting, Cloud Hosting or similar service, or make the Software Application available to third parties via the Internet on End-User's computer system or otherwise.

The Licensee shall not modify, translate, adapt, arrange, or create derivative works based on the Software Application for any purpose. The Licensee may not use or export the Software Application outside of the country of purchase for any reason. The Licensee shall not assign, give or transfer the Software Application to another individual or entity. The Licensee is prohibited from (a) timesharing, service bureau, subscription service or rental use of the Software Application or (b) passing title to the Software Application any other individual or (c) publication of any results of benchmark tests run on the Software Application. The Licensee acknowledges that the Software Application is the confidential information of CADS and its suppliers, and the Licensee agrees that under no circumstances may the Licensee disclose the Software Application to any third party.

## 1.5 Payment of License Fees

In consideration of the grant of the License, the Licensee agrees to pay CADS all license fees and other related charges payable by virtue of the provisions of this License and acknowledges that CADS may issue upgraded versions of the Software Application to the Licensee at an extra fee, the amount of which will be determined at the absolute discretion of CADS. The Licensee shall be entitled to receive the upgraded Software Application only after it has paid CADS the notified fee.



## 1.6 Enhancement and Variations to the Software Application

The Licensee shall not enhance or vary any part of the Software Application nor permit the whole or any part of it to be incorporated in any other software or used on any other equipment without the prior written consent of CADS.

## 1.7 Additional Licenses

Pursuant to a request made by the Licensee, CADS will provide additional licenses to increase the number of licensed Software Application users subject to the Licensee paying the then current market price and cost of the Software Application.

## 1.8 Use of the Software by the Licensee

The Licensee shall use the Software Application on the device or system at each and every location where it is installed in accordance with the following and for the purpose of this License, Use of Software Application shall mean:

The certificate shall also mention the number of systems the Software has been deployed on and the details thereof. ### 1.11 Users of Software

The Licensee agrees that the Software Application will only be used by suitably trained and skilled staff and employees as an aid to design and specification and it is not intended as and must never be used as a substitute for professional skill, experience or expertise. The Licensee should always ensure that users of the Software Application either have themselves the necessary skill and experience or recourse to the necessary advice specific to the circumstances for which the software is being used and that it is not a substitute for on-site assessment.

### 1.12 Maintenance and Support

CADS agrees to supply the Licensee with maintenance and support services ("CADScover") conditionally upon the Licensee signing and returning a Software Maintenance and Support Agreement,

Upon receipt of a signed Software Maintenance and Support Agreement together with the annual charge in advance, CADS shall issue a CADScover registration card and a countersigned copy of the Agreement bearing the respective registration number to the Licensee.

## 1.13 Intellectual Property & Confidentiality

The Intellectual Property Rights in the Software Application will be the sole property of the Licensor and the Licensee will have the limited right to the use of the Software Application as provided in this License Agreement.

Subject to the rights granted to the Licensee by this License, the Licensee acknowledges that all and any proprietary rights with respect to the Software Application worldwide, (including but not limited to copyright) and in all associated documentation and other materials related to the Software Application shall be and remain the sole lawful property of CADS and its suppliers.

The Software Application and all the information, data, drawings, sketches, specifications, documents, software listings, source code, or object code is proprietary, secret and confidential information possessed and legally owned by CADS. The Licensee hereby agrees that it shall use such information solely in accordance with the provisions of this License and that it shall take all measures necessary to maintain confidence and secrecy in the Software Application both for the duration of this License and after its termination, howsoever caused. Disclosure shall be limited to those members of the Licensee's staff who need access to the Software Application to enable the Licensee to exercise this License and shall not be available to any third party. These confidentiality obligations extend to the structure, sequence, organisation and screen presentation of the Software Application.

The Licensee undertakes to:

- (a). promptly notify the Licensor of the infringement of any of the Intellectual Property Rights relating to the Software Application which the Licensee has actual knowledge of; and
- (b). take such reasonable steps to assist the Licensor in any enforcement proceedings commenced by the Licensor for infringement of any of its Intellectual Property Rights provided that all the costs and expenses incurred in such proceedings shall be borne by the Licensor.

In the event that by virtue of, or pursuant to, any applicable law, any Intellectual Property Rights arising out of or in connection with the License vests with the Licensee, then in consideration of the License, the Licensee hereby irrevocably assigns such Intellectual Property Rights in favour of the Licensor on a royalty free basis.



## 1.14 Indemnity and Warranties

CADS warrants to the Licensee that the Software Application will not infringe any copyright, patent or other intellectual property rights of any third party.

The Licensee shall promptly give notice to CADS of any claim alleging infringement of any intellectual property right of any third party by the Software and CADS shall at its discretion either compromise or defend such claims. CADS shall have the right to replace or change the Software Application so as to avoid infringement of any third party's intellectual property rights.

CADS warrants that for a period of 90 days, the Software Application when delivered will perform substantially in accordance with CADS's published specifications but does not warrant that the Software Application is error free. Faulty media and documentation will be replaced during the warranty period free of cost, on receipt by CADS of written notification from the Licensee setting out details of such error.

The Licensee is responsible for loss or damage of all dongles received from CADS as part of the License. In case of loss of a dongle, CADS has the right to terminate the License and CADS is not obligated to replace any lost dongle. Damaged dongles may be returned to CADS and will be replaced, but CADS reserves the right to charge additional fees to cover the costs in that case. This warranty does not apply if the defect or fault in the Software Application results from the Licensee having amended or attempted to amend the Software Application or if the defect or fault in the Software Application results from the Licensee having used the Software Application in contravention of the terms of this License.

The Licensee shall indemnify the Licensor against all such claims, loss and liabilities in the following events:

- a) the Licensee has altered or modified the Software Application in any way;
- b) the Licensee uses the Software Application in combination with any other software/program thereby causing damage/modification to it;
- c) the Licensee uses the Software Application in any manner other than as expressly permitted under this License Agreement; and

## 1.15 Liability

CADS and its suppliers shall not be liable for any loss or damages, direct or indirect, consequential or financial suffered by the Licensee caused by the delivery, use or performance of the Software Application or for negligence or breach of contract by CADS in relation to the Software Application whether foreseeable or not and regardless of whether the Licensee or its suppliers have been advised of the possibility of such damages.

## 1.16 Liability Limits

Other than the losses set out in Clause 15 (for which CADS are not liable) the maximum aggregate of the liability of CADS under or in connection with this License whether in contract, tort (including negligence) or otherwise, shall in all circumstances be limited to the price paid for the Software Application.

Nothing in this license shall limit or exclude our liability for:

- (a) death or personal injury resulting from our negligence
- (b) any other liability that cannot be excluded or limited by English law.

## 1.17 Privacy Statement

CADS respects your right to privacy. Our software may collect and analyse general usage information about the hardware, its configuration, software usage patterns and error reports to help us improve the quality of our service. We will not collect personal information about individual users and do not sell or otherwise give away any such information to unaffiliated third parties unless legally compelled to do so.

## 1.18 Audit Rights

At any time during the term of this License, CADS or its re-seller in any location may conduct or appoint an external auditor to conduct an audit in order to ensure compliance by the Licensee with the terms of

any Licenses of CADS Software Applications. CADS or its re-seller as applicable shall provide no less than five days advance notice of audit to the Licensee unless the Audit is carried out electronically.

The Licensee shall grant the Licensor CADS or the appointed external auditor reasonable assistance and cooperation and such access to premises, systems and other such material and data as may be reasonably necessary to determine the Licensee's compliance with any CADS licensing agreements. CADS or its external auditor shall ensure that such Audit will not interfere unreasonably with the legitimate business activities of the Licensee.

The Audit may also be conducted electronically utilising the audit functionality of the Software Application designed to enable CADS to automatically monitor the use of its software. ## 1.20 Length of License

This License shall commence by the execution of this agreement between the parties and shall continue for a period of 5 (five) years unless otherwise terminated. The Licensee may terminate this License by giving 90 days' written notice to CADS on its ceasing to use the Software Application for the purposes of their business. Upon expiry of 5 (five) years, the License shall stand automatically terminated unless the Licensee has executed another agreement with terms and conditions as specified by CADS. Any usage of the Software Application beyond the period of 5 (five) years, without the consent of CADS, shall be regarded as an unauthorized use of the Software Application.



## 1.21 Termination

CADS may terminate the Licensee's right to use the Software Application under this License on 30 days' written notice if the Licensee breaches any of the terms, conditions, or provisions of this License or any obligation to CADS required by law or without prejudice to clause 18 above, if the Licensee fails to pay any sum due to CADS whether due under this License or not and/or if the Software Maintenance and Support Agreement is terminated (for whatever reason) if the Licensee, being a body corporate, shall present a petition or have a petition that is not discharged or stayed within 30 days presented by a creditor for its winding up, or shall convene a meeting to pass a resolution for voluntary winding up, or shall enter into any liquidation (other than for the purpose of a bona fide reconstruction or amalgamation); shall call a meeting of its creditors, or shall have a receiver of all or any of its undertaking or assets appointed, or shall be deemed by virtue of section 123 of the Insolvency Act 1986 to be able to pay its debts.

## 1.22 Return of Software and Documentation

On termination for whatever reason, the Licensee shall return immediately all copies of the Software Application and associated documentation to CADS and shall pay to CADS all costs and expenses, including legal and other fees incurred and all arrears of fees, charges and other payments arising in respect of the Software Application and the total amount of any License fees outstanding under this License or otherwise. Termination, howsoever or whenever occasioned shall be subject to the any rights and remedies CADS or its suppliers may have under this License or in law.

## 1.23 Notices

All notices to be given under this License shall be in writing and be presented at or posted to the addresses as indicated on the Confirmation of Order Form unless otherwise advised in writing. Notices shall be effective when presented at such addresses or 48 hours after posting if mailed by ordinary first-class post.

## 1.24 Assignment

The Licensee shall not be entitled to assign this license or any of its obligations hereunder. The Licensee agrees that CADS shall be entitled to assign or sub-contract its rights and obligations under this Agreement to a third party and the Licensee agrees to enter into a novation of the License to achieve such an assignment by CADS if CADS so directs the Licensee.

## 1.25 Third Party Rights

Nothing in this License shall confer on any third party, any right to enforce any term of this License under the Contracts (Rights of third Parties) Act 1999.

## 1.26 Taxes

All charges and fees paid are exclusive of and do not include any taxes, duties, or similar charges imposed by any government. The Licensee agrees to pay or reimburse CADS for all federal, state, national, dominion, provincial, or local sales, use, personal property, excise, VAT or other taxes, fees or duties arising out of this agreement or the transactions contemplated by the Agreement.

## 1.27 Law

The parties hereby agree that the License concluded between them constructed on these terms and conditions shall be construed in accordance with English Law and the parties shall submit to the non-exclusive jurisdiction of the English Courts.

## 1.28 Headings

The headings of the terms and conditions herein contained are inserted for the convenience or reference only and are not intended to be part of or to affect the meaning or interpretation of any of the terms and conditions of this License.

## 1.29 Force Majeure

No Party shall be liable for, nor shall any party be considered in breach of this Agreement due to any failure to perform its obligations under this Agreement as a result of a cause beyond its control ( each a "Force Majeure Event"), including any act of God or a public enemy, any act of terrorism, act of military, civil or regulatory authority, change in law or regulation, fire , flood, earthquake, storm or other like event, disruption outage of communications, power or other utility, labour problem, unavailability of supplies, or any other cause, whether similar or dissimilar to any of the foregoing; provided, however that upon learning of any Force Majeure event, the applicable party shall immediately notify the other party of such Force Majeure Event.

## 1.30 Entire Agreement

This License constitutes the entire agreement between the parties in relation to its subject matter and supersedes any prior agreements on these matters and any such agreements shall cease to have any

further effect. It is also agreed that neither party has relied upon any representations nor other statements in entering into this License other than those set out herein. No purported amendments to this License shall be effective unless in writing and signed by duly appointed representatives of all parties.

### 1.31 Acknowledgement

The Licensee and/or the End User acknowledges to have read the license, understand the same and agree to be bound by its terms and conditions.

### 1.32 Severability

In the event that any of these terms, conditions, provision shall be determined invalid, unlawful or unenforceable to any extent, such term, condition or provisions shall be severed from the remaining terms, conditions and provisions which shall continue to be valid to the fullest extent permitted by law.

### 1.33 Waiver

Failure or neglect by CADS to enforce at any time any of the terms of this License shall not be deemed to be a waiver of CADS rights hereunder nor in any way affect the validity of the whole or any part of this License nor prejudice CADS rights to take subsequent action.

### 1.34 Export Control

This software product may be subject to trade compliance and export control regulations in the UK and in other jurisdictions, such as the US and EU. By downloading this software, you agree to comply with such applicable laws. CADS reserves the right to terminate your licence if you are found to be affected by such regulations.

### 1.35 Refund Policy

Refunds will only be given under exceptional circumstances and are purely at CADS' discretion. No refunds will be granted more than 15 days after payment.
